For the EnviroServer ES Series wastewater treatment system ("System") cited above, MST Manufacturing, Inc. ("DBA MicroSepTec") through Crewe Tecnhologies Inc., hereby agrees to notify the Owner, and Service Provider set forth above of any alarms emanating from the system, including, as appropriate, High-level alarms, UV Disinfection alarms and Low Air alarms. The "System" refers only to EnviroServer identified by the serial number set forth above. The Service Provider will be notified via email and/or text of any alarms, according to the data set forth above.

Property owner agrees to pay an annual fee of \$15.00 Service will be activated once payment has been received and subsequent billing will be billed in advance by MicroSepTec (or affiliated billing company) for this monitoring service. Initial Year of Service can be billed through the This cost includes remote notification of alarm conditions, and historic data of alarms maintained by the Telemetry system. Property owner further agrees to pay a fee of \$25 for each change in system or contact information submitted. Property owner agrees to have the Authorized Service Provider listed for notifications of system alarms from the EnviroServer System. The property owner and Service Provider acknowledges that failure to pay service fees or maintenance fees within 30 days of invoicing will result in a discontinuance of monitoring by MicroSepTec and that any local regulatory agencies, if applicable, will be notified of such discontinuance. Service Provider understands that a valid Internet connection is required preferably by network cable connected directly to the router or via wireless connection and that it is the Service Provider's responsibility to ensure such a connection. Wireless connections are less reliable and inconsistent in performance. MicroSepTec responsibility, regarding notification of alarms, is null and void in the absence of such a connection or payment for services.

Concurrent with the execution of this Agreement, Service Provider shall enter into and execute a maintenance agreement with Property Owner and will maintain the system according to MST's specifications and will submit any required reports to MST and regulatory agencies, when applicable, in accordance with the Authorized Service Technician Agreement.
